A calibration of the Architectural Testing Inc. 'thermal test chamber' (ICN 000001) in York, Pennsylvania was conducted in April 2008 in accordance with Architectural Testing Inc. calibration procedure.

Prior to testing the specimen was sealed with silicone on the interior side and checked for air infiltration per Section 9.3.4.


